Apply 64 - 191 ml of Green-T[®] 0-0-27 per 100 m² (2 - 6 oz. per 1,000 sq. ft.) or 6- 20 L per Ha (0.7 - 2.0 gallons per Acre) every 10 - 21 days in a minimum of 815 Litre of water per Ha (2 gallons of water per 1,000 sq. ft.)

To enhance plant uptake, do not mow or irrigate treated areas until spray has completely dried. Apply at 2 week intervals and repeat as needed. Rate and frequency of application may vary due to active growth periods and grass cultivars.

Fairways, Roughs, Sports Turf & Lawns:

Apply 10 - 14 L of Green-T[®] 0-0-27 per Ha (1 - 1.5 gallons per Acre) or 95 - 140 ml per 100 m² (3 - 4 oz. per 1,000 sq. ft.) every 14 days during active growth period. Apply in a minimum of 815 L of water per Ha (2 gallons of water per 1,000 sq. ft.)
